To: The Competitor of car No. 38 DIEGO H. DOMINGUEZ S.

Hyundai Motorsport

The Stewards, having received a report from the FIA Technical Delegate, summoned a representative of the above competitor as well as representatives from Hyundai Motorsport, have considered the following matter and determine the following:

Facts The ECU software used on car 38 did not match with the homologated software

when checked on Friday, April 27.

Offence Art. 10.3.3 of the 2018 FIA International Sporting Code

Art. 261-02-3, Appendix J to the 2018 FIA International Sporting Code.

Decision To impose a fine of € 30000 on Hyundai Motorsport, € 25000 of which being

suspended and to become immediately payable should Hyundai Motorsport commit a similar infringement – ECU software not conforming – before the end of the 2019

WRC season.

Reason The hearing was held on Saturday, April 28 at 15:30 hrs and attended by

representatives of the competitor, Robert Hermans, Team Manager and Jorge de la Fuente, Support Engineer. Hyundai Motorsport was represented by Michel Nandan, Team Principal and Laurent Lebastard, Electronics Systems Engineering. Jérôme Toquet, FIA Technical Delegate and Clément Clerc, Assistant to the FIA Technical

Delegate were also present.

During the hearing, Mr. Hermans explained that they had received the rally car as such from Hyundai Motorsport in February 2018 and no modifications had been made to the ECU Software.

Mr. Nandan explained that they had ordered a batch of ECUs from the supplier that were by mistake not exactly similar to those they were supposed to receive. He added that it is possible to correct this difference with a software update, but not being aware of all ECUs that were affected, this particular ECU was not updated.

According to the FIA Technical Delegate, Hyundai Motorsport has had several ECU software related issues in the past and had been advised to pay more attention on this matter.

As updating the ECU during this rally would potentially put at risk its proper functioning and as no spare ECUs are currently available, it was agreed that Hyundai Motorsport updates and verifies the ECU together with the FIA Technical Delegate immediately after this rally.

After due deliberation, the Stewards conclude that, as a manufacturer, Hyundai Motorsport must make sure that the parts they deliver to customers comply with the regulations. Therefore, under Article 12.4.1 in conjunction with Article 12.2.1 of the 2018 FIA International Sporting Code, the penalty is imposed on Hyundai Motorsport.

Under these circumstances, no further action is taken against the competitor.
